Experience: Approved mediators have completed at least 250 hours of face-to-face family mediation in at least 25 different cases.

Ms. Magruder's style of mediation is primarily a facilitative approach where the process of mediation is structured to the extent necessary to allow parties the opportunity to communicate openly about their wants and needs for resolving a dispute. The organization of the process allows parties to better manage their conflict. Parties are encouraged to talk about what is important to them and are the ultimate decision-makers as to the outcome of the mediation. Ms. Magruder believes that any decision parties make for themselves after exploration, investigation, and consideration of all the issues that are important to them is better than any decision that could be made for them. One of Ms. Magruder's strategies is to focus on creative solutions, which emerge as a result of thinking "out of the box." Parties are encouraged to negotiate in a way that allows them to meet each other's needs without compromising their own values. Part of the goal in mediation is to educate parties in negotiation techniques, both

by the mediator's example and by use of parties' interactions as demonstrations, so they will have tools for resolving future conflicts.

As President of the Conflict Resolution Center International, (1981-2003) Paul actively chronicled and highlighted the major issues and developments in the field in the publication he edited, Conflict Resolution Notes. He co-authored The MOVE Crisis in Philadelphia: Extremist Groups and Conflict Resolution, which has become a standard text. His most recent book is Community Dispute Resolution, Empowerment and Social Justice. He chaired the board of the National Conference on Peacemaking and Conflict Resolution (1991 - 1995). He was a founding member of the Board of Directors for the European Conference on Peacemaking and Conflict Resolution, 1991 - to 1996. In 1999 the National Conference on Peacemaking and Conflict Resolution honored him with the Margaret Herrman Award for his lifetime contributions to the conflict resolution field.
