Introduction to Mediation News.

This month's "Mediation News" includes a blog on the lower right entitled "It Ain't Easy to Say 'I am Sorry.'" It describes research on good and poor ways to apologize. The subject also reminds us of the power of saying "I 'm sorry." Years ago the *Wall Street Journal* featured a page one story on the shift that major insurance companies were making by encouraging their doctor-insureds to apologize when they wished to express remorse.

While periodically considered during mediations, possible apologies are often rejected because the facts are rarely one-sided and/or the emotions on both sides are aroused. In fact, the speaker has options such as, "We have business considerations which require our position, but I am sorry that you had that experience."

So often the core emotion driving a lawsuit is the plaintiff's feeling that s/he was not only wronged, but that those responsible simply did not care. For that reason, where the opposing party regrets what the plaintiff experienced, that regret can be expressed without undermining its legal position. By doing so, the defendant contradicts the core emotion underlying the lawsuit, humanizes its representative/s and demonstrates that that party has heard what the plaintiff strongly feels. There may be factors which make an apology inappropriate, but they are best considered with the impact which an apology can have on efforts to end litigation.


